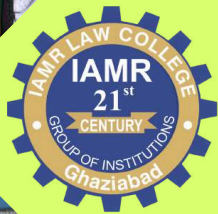

The students of IAMR Law College visited Manandham as part of a plantation drive. This visit aimed to promote environmental awareness and responsibility among the students.

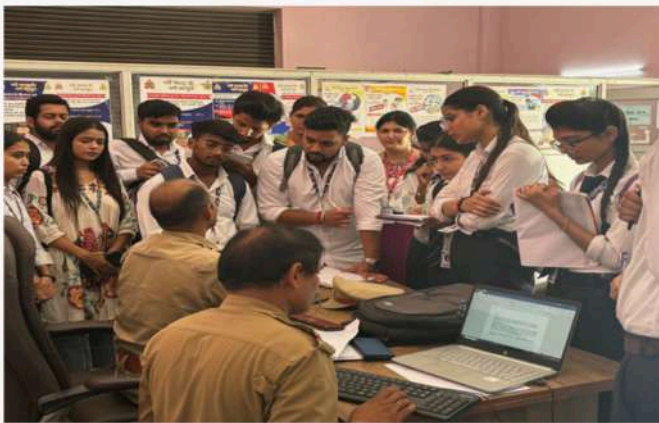


Students actively participated in planting saplings across the designated area, learning the importance of tree plantation in combating climate change and improving biodiversity.
